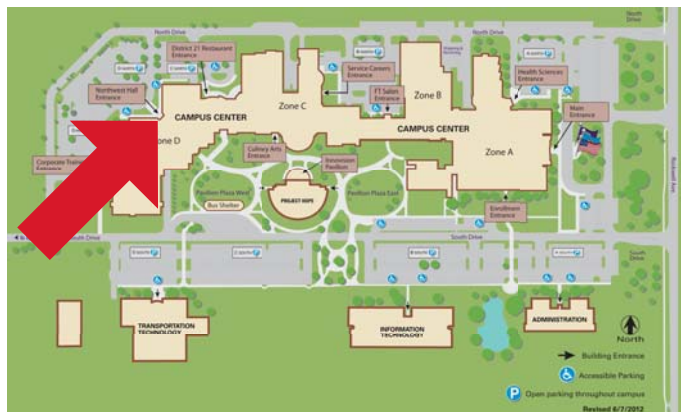
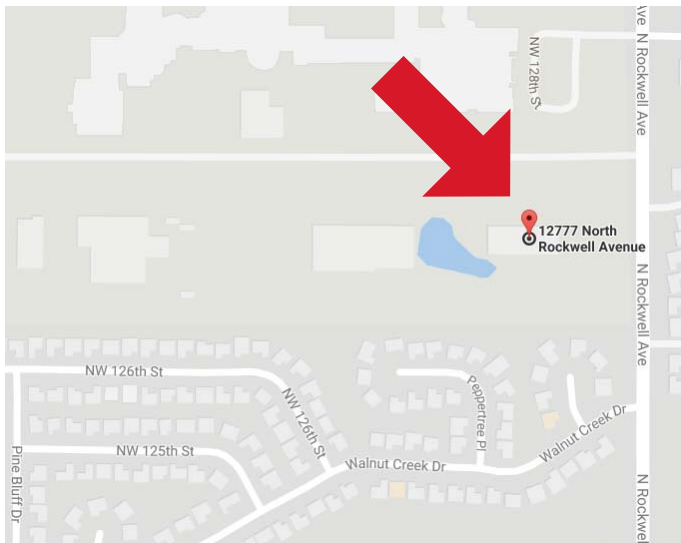

She is an ACA Fellow. Dr. Bradley received the 2016 award from Counselors for Social Justice for her work on advocacy and the 2017 ACES Leadership Award for leadership within the profession. She is a Licensed Professional Counselor/Supervisor (TX), Licensed Marriage and Family Therapist/Supervisor (TX) and National Board Certified Counselor. She is a frequent author and a presenter at international/national and state conferences.
